

## Application for Ad Hoc Permit to Carry Dangerous Goods by Air (Foreign Operator)

**Note** - Application shall be made **at least 10 working days** prior to the intended date of carriage. In case the proposed flight involves transport of dangerous goods which are specified by the ICAO Technical Instructions that goods may be carried with an approval/exemption by the Civil Aviation Authority – Macao, China, the approval/exemption application shall be submitted in conjunction with this application for pertinent evaluation.
