Things to follow

- Drone operation must comply with all the provisions of Article 67 of the Air Navigation Regulations Macao, however the restrictions on flight altitude stated in paragraph 3b of Article 67 can be waived in case of obtaining permission from this authority and drone should fly according to the Operation Height Limit Chart. << Air Navigation Regulations Macao>> Article 67 Please see: <https://www.aacm.gov.mo/images/download1/2019102415034640.pdf>
- Drones must fly during daylight.
- Drones are prohibited from flying over any borders and ports in the Macao SAR.
- When flying, the drone needs to maintain a distance of 50 meters from the light rail train lines and its facilities.
- Drones are prohibited from flying over crowd gathering locations and large event venues
- Drones are prohibited from flying over all Macau Cross-sea Bridges.
- If necessary, the Civil Aviation Authority Macao may restrict or prohibit any authorized drone operations in accordance with the provisions of Article 66 of the Air Navigation Regulations Macao. Before launching the drone, you should visit AACM website <http://www.aacm.gov.mo> to read the no-fly information.
- When using drones to move over all real estates assessed as cultural relic buildings and their surrounding areas, the drones must maintain a proper distance from these buildings, and the operators should also perform flight operations under safe conditions. - Drones are prohibited from flying over the The Ruins of Saint Paul's.
- During thunderstorm warnings, heavy rain warnings, and strong monsoon signals come into effect, or weather conditions fail to meet the drone flying specifications, operators must not fly drones.
- Relevant approval does not exempt the necessary procedures, relevant regulations and third party liability insurance required by other entities or Authorities.
- Pursuant to Article 16 of Decree No. 52/94 / M of November 7, 1994, this Authority has the right to impose a fine on anyone who conducts activities in areas subject to aviation rights and does not comply with the conditions of this permit.
