SUBJECT: Written examination for Flight Crew License

- 1. In accordance with paragraph 3(1)(c) and paragraph 4(b) of the Eighth Schedule of the Air Navigation Regulation of Macao, a person applying for the grant of an Air Transport Pilot License (ATPL) or applying for the conversion of a flight crew license on the basis of a valid similar license granted by other competent civil aviation authorities is required to pass such examinations as deemed necessary by the AACM.
- 2. The Airline Transport Pilot License (Aeroplane or Helicopter) written examinations is only intended for holder of a valid Macau CPL(A/H) who wishes to apply for ATPL(A/H) correspondingly. The examination schedule **from January to June 2025** will be held as follows:
