3. An official letter of approval of the Security Programme/WP will be sent after the approval is granted by mail or electronically.
4. In the checklist, Y means Compliance, N means not compliance and state the target compliance date in the remark column, N/A means non applicable and state reason in the remark column, programme reference means chapter, section and paragraph reference of the AOSP/WP e.g. AOSP/WP Chapter 15, section 1.4.1.
