


Declaration Form for Alternate Flight with Security Weapons on Board an Aircraft

MIA LOGO	<u>For Alternate Flight</u>		
Declaration on security weapons reasonably carried on board under the law of State in which the aircraft is registered <i>According to relevant law and regulation in Macau, it is a criminal offence for any person to provide information that is false or misleading in a declaration. On conviction, you are liable to a fine or imprisonment.</i>			
The Pilot in Command or Flight Officer of each aircraft making an alternate landing at Macau International Airport must provide the following information, and declare all security weapons (Firearms, magazines, bullets and other security weapon) that are reasonably carried on board.

14.	<p>Important information:</p> <p>(a) Corpo de Polícia de Segurança Pública (CPSP) is responsible for protecting Macau SAR against illegal use and importation of weapons. CPSP officers have the authority to question you and instruct you on the handling of all declared security weapons carried on board aircraft.</p> <p>(b) If flight crew need to leave the aircraft, they shall handover all declared security weapons to CPSP for storage. If the air operator does not have a representative in the airport, the PIC or FO shall request the ground handling company at the MIA act as the air operator's representative to perform steps related to the handover procedures.</p>		
15.	<p>Personal Data Collection Statement (PICS)</p> <p>(a) The personal data provided will be used by Macau International Airport Co. Ltd. for the purpose of processing the handling of security weapons carried on board an aircraft, in order to prevent relevant items from being illegally acquired and used at Macau International Airport.</p> <p>(b) The Macau International Airport Co. Ltd. will transfer the personal data collected in this declaration form to Corpo de Polícia de Segurança Pública and  Serviços de Alfândega for the purpose stated in item A. above.</p> <p>(c) You are required to provide all the information requested in this declaration form, if you fail to provide, it may affect the processing of this declaration.</p> <p>(d) According to the law, you may make a request to Macau International Airport Co. Ltd to access, correct or update your personal data.</p>
