## Introduction of service

Evaluation and approval for the application of certification of airworthiness of aircraft.

#### Service target and eligibility criteria

For an aircraft that has already been type accepted by the Civil Aviation Authority, the registered owner of the aircraft may submit the application for the Certificate of Airworthiness of Aircraft to the Civil Aviation Authority.

#### Result

Issue certification of airworthiness of aircraft to eligible applicant.

#### Charge

The issuance fee for the Certificate of Airworthiness of Aircraft is based on the maximum take-off weight (MTOW) of the aircraft as follows:

3,000 kg and below: MOP8,000 plus stamp duty 3,001 kg to 15,000 kg: MOP13,000 plus stamp duty 15,001 kg to55,000 kg: MOP 17,400 plus stamp duty 55,001 kg to 160,000 kg: MOP 24,000 plus stamp duty 160,000 and above: MOP 32,000 plus stamp duty

Note: The fee should be paid at the time the application is submitted.

# **Processing time**

The approval process will not take more than 70 working days to complete (time guaranteed in performance pledge).

Note: The time guaranteed commences from the next day following the day of submission of all documents or information.

## Charge

The renewal fee for the Certificate of Airworthiness of Aircraft is based on the maximum take-off weight (MTOW) of the aircraft as follows:

3,000 kg and below: MOP6,000 plus stamp duty 3,001 kg to 15,000 kg: MOP9,000 plus stamp duty 15,001 kg to55,000 kg: MOP MOP 13,000 plus stamp duty 55,001 kg to 160,000 kg: MOP 18,000 plus stamp duty 160,000 and above: MOP 24,000 plus stamp duty

Note: The fee should be paid at the time the application is submitted.

The renewal process will not take more than 20 working days to complete (time guaranteed in performance pledge).
