

SUBJECT: Written examination for Flight Crew License

1. In accordance with paragraph 3(1)(c) and paragraph 4(b) of the Eighth Schedule of the Air Navigation Regulation of Macao, a person applying for the grant of an Air Transport Pilot License (ATPL) or applying for the conversion of a flight crew license on the basis of a valid similar license granted by other competent civil aviation authorities is required to pass such examinations as deemed necessary by the AACM.
2. The Airline Transport Pilot License (Aeroplane or Helicopter) written examinations is only intended for holder of a valid Macau CPL(A/H) who wishes to apply for ATPL(A/H) correspondingly. The examination schedule **from July to December 2025** will be held as follows:
