The applicant must be employed by a Macao registered operator and meets the following conditions:

1. must be 21 years of age or above;
2. Pass all the required training and be qualified to apply for the Flight operations officer license.
3. Pass all required written examinations administered by the Civil Aviation Authority.

Issue operations officer license to eligible applicant.

4. Employment certificate;
5. Copy of the valid flight operations officer license issued by an ICAO Contracting State (applicable to license conversion only);
6. Documents certifying the successful completion of an approved operator-specific training course, including the on-the-job training.
7. Other additional documents or information as requested by the Civil Aviation Authority of Macao.
