

# Pilot License

## Introduction of service

Evaluation and approval for pilot license.

## Service target and eligibility criteria

The applicant must be employed by a Macao registered air operator and meets the following conditions:

1. must be between 18 and 60 years of age (in special circumstances, it can be extended to 65 years of age)
2. pass all the Macao Class 1 Medical Assessment;
3. pass all required training and checks approved by the Civil Aviation Authority;
4. pass all required written examinations administered by the Civil Aviation Authority;
5. pass all the Macao Language Proficiency Test administered by the Civil Aviation Authority.

Note:

- The applicant for Commercial Pilot License must be 18 years of age or above.
- The applicant for Airline Transport Pilot License must be 21 years of age or above

## Result

Issue pilot license to eligible applicant.

#### **Application procedure and required documents**

The applicant is required to submit the following documents or information:

1. The completed application form ([Application for Flight Crew License And/Or Rating PEL/APP/001a](#));
2. Original and copy of valid professional pilot license issued by an ICAO contracting state; (applicable to license conversion only), or holds a valid Macao Commercial Pilot License (applicable to license upgrade to ATPL only);
3. A proof of nationality in which the information (e.g. name, nationality, date of birth, etc.) shall be consistent with the license in the item 2 above;
4. Two recent 1.5-inch color photographs (dimensions of the photographs must be 45mm high by 35mm wide taken in plain white background without margin);
5. Personal flying log book(s) with the last six months entries;
6. Documents certifying the successful completion of an appropriate training course;
7. Employment letter issued by the airline registered in Macao;
8. A proof confirming the completion of check rides conducted by a Civil Aviation Authority authorized examiner;
9. Other additional documents or information as requested by the Civil Aviation Authority.
