SUBJECT: *Notification of illness, injury or pregnancy by holder of
an air traffic controller licence*

1. The holder of a Macao air traffic controller licence is required by paragraph 65(1) of the Air Navigation Regulations of Macao (ANRM) to inform the Civil Aviation Authority (AACM) of certain medical conditions. Under such medical conditions the licence is deemed to be suspended.
2. In the case of injury or illness, the suspension shall cease upon the holder being medically examined and assessed by a Designated Aviation Medical Examiner (AME) as fit to resume his/her functions as an air traffic controller.
3. In the case of pregnancy, the suspension shall remain in force unless evaluated by a Designated AME as fit, or until the holder has been medically examined after the pregnancy has ended and pronounced fit to resume her functions under the licence by a Designated AME.
4. In any case, the licence holder is reminded to inform the Designated AME of his/her case of injury, illness or pregnancy. The Designated AME will send a dedicated form to notify the AACM of the result.
5. For the purpose of fulfilling paragraph 65(1) of the ANRM, the holder of a Macao air traffic controller licence may either:
 - a) complete the notification form (PEL/APP/015) and send to AACM by post or by fax; or
 - b) make online application through the ALMS online application system

6. The list of Designated AME is updated periodically through the Macao AIC B series.
7. Please note that medical examination reports resulting from paragraphs 2 and 3 above are also subject to the review of the medical assessor (See AIC B 03/09 dated 01 Mar 2009).

SUBJECT: Notification of injury, illness or pregnancy by Macao air traffic controller licence holder

In accordance with the Air Navigation Regulation of Macao Part IX paragraph 65(1), I hereby inform the Civil Aviation Authority of the following (please tick as appropriate):

☐ I suffered a personal injury/illness¹ on _____ (dd/mmm/yyyy) involving incapacity to undertake the functions to which my licence relates throughout a period of 20 days or more; or

☐ I have reason to believe that I am pregnant.

I understand that my licence of number stated above is deemed to be suspended according to the Air Navigation Regulation of Macao Part IX paragraph 65(2) or paragraph 65(3) as applicable, and

a) The suspension of licence due to injury/illness shall cease:

- (i) upon I am medically examined by a Designated Aviation Medical Examiner and pronounced fit to resume my functions under the licence; or
- (ii) upon the Civil Aviation Authority exempting me from the requirement of a medical examination, subject to such conditions as the Civil Aviation Authority may think fit.

b) The suspension of licence due to pregnancy:

- (i) may be lifted subject to the evaluation of a Designated Aviation Medical Examiner, or
- (ii) shall cease upon being medically examined by a Designated Aviation Medical Examiner after the pregnancy has ended and pronounced fit to resume my functions under the licence.
