Introduction of service

Evaluation and approval for Flight Operations Officer Licence.

Service target and eligibility criteria

The applicant must be employed by a Macao registered operator and meets the following conditions:

1. must be 21 years of age or above;
2. pass all the required training and be qualified to apply for the Flight Operations Officer Licence.
3. pass all required written examinations administered by the Civil Aviation Authority.

Result

Issue Flight Operations Officer Licence to eligible applicant.

1. a completed application form ([Application for Flight Operations Officer License PEL/APP/005](#))
2. a proof of nationality;
3. one passport size recent color photo;
4. employment certificate;
5. copy of the valid flight operations officer Licence issued by an ICAO Contracting State (applicable to Licence conversion only);
6. documents certifying the successful completion of an approved operator-specific training course, including the on-the-job training;
7. other additional documents or information as requested by the Civil Aviation Authority of Macao.

3. proof of recent experience showing that he / she has exercised the appropriate privileges of the Licence in the last 12 months preceding the expiry date of the Licence;
4. documents confirming the successful completion of an approved operator-specified training course;
5. other additional documents or information as requested by the Civil Aviation Authority.
