Introduction of service

Evaluation and approval for air traffic controller license application.

Service target and eligibility criteria

Student air traffic controller license:

- Must be 18 years of age or above;
- Pass all required training approved by the Civil Aviation Authority;
- Pass all required written examinations administered by the Civil Aviation Authority;
- Pass the Macao Class 3 Aviation Medical Assessment.

Air traffic controller license:

- Must be 21 years of age or above;
- Pass all required training (including on-the-job training) approved by the Civil Aviation Authority;
- Pass the Macao Class 3 Aviation Medical Assessment;
- Pass the Language Proficiency Test administered by the Civil Aviation Authority;
- Pass a competence check conducted by an AACM authorized ATC Examiner.

Result

Issue student air traffic controller license or air traffic controller license to eligible applicants.
