Service target and eligibility criteria

MAR-66 aircraft maintenance engineer examination:

- Applicant who wishes to apply for a MAR-66 Aircraft Maintenance Engineer License.

Pilot license examination:

- Applicant who wishes to convert a foreign license to a local license, or
- Holder of a commercial pilot license who wishes to apply for the grant of local airline transport pilot license.

Note:

- The applicant for commercial pilot license examination shall not be less than 18 years of age and have a valid local or foreign commercial pilot license
- The applicant for airline transport pilot license examination shall not be less than 21 years of age and shall have a valid local commercial pilot license or valid foreign airline transport pilot license.

Air traffic controller Licensing examination:

- A person who wishes to apply for Air traffic controller examination.
- The applicant shall not be less than 18 years of age and has already successfully completed all the required trainings certified by the Civil Aviation Authority.

Release the examination result.
