

Registration of Aircraft

Introduction of service

Evaluation and approval for registration of aircraft.

Service target and eligibility criteria

Resident of Macao or companies incorporated in Macao can submit application for Certificate of Registration to the Civil Aviation Authority. Only aircraft which satisfies the conditions set forth in Paragraph 4(2) of the [Air Navigation Regulation of Macao](#) (ANRM) is eligible for registration in Macao. Relevant aircraft type must have been type accepted by the Civil Aviation Authority.

Result

Issue the Certificate of registration of aircraft to eligible applicants.

Application procedure and required documents

The applicant is required to submit the following documents in writing:

1. Completed application form [AW/APP/001](#) and the required document specified therein;
2. A legal document proving that the applicant satisfies the eligibility criteria;
3. Aircraft photograph;
4. Other evidence in support of the application as the Civil Aviation Authority may reasonably require for the consideration of the application.

Charge

The fees charged by the Civil Aviation Authority are as follows:

Issuance of the certificate: MOP 500, plus applicable stamp duty. For aircraft exceeding 3,000 kg, an additional charge of MOP 50 will be levied for each additional 1,000 kg or part thereof.

Note: The fee shall be paid at the time of application submission.

Processing time

The approval process will not take more than 30 working days to complete (time guaranteed in performance pledge).

Note: The time guaranteed commences from the next day following the day of submission of all documents or information.
