

# Initial Application for Unmanned Aircraft (UA) Operator Permit

## Personal Data Collection Statement

The personal data provided for this application will only be used for purposes directly related to this application. For the purpose of fulfilling statutory obligations, relevant information may be transferred to police authorities and other authorized entities.

Note : UA Operator permit is required for operation of unmanned aircraft having total mass **exceeding 7 kg but not exceeding 25 kg** in Macao

- This application shall be made **at least 2 months** prior to the proposed commencement date of the intended operations.
- Before completing this form:
  - Please read Aeronautical Circular, AC/GEN/013 - *Operator Permit for Unmanned Aircraft Operations in Macao*.
  - The applicant for UA operator permit shall register an account through the AACM "Online Application for Drone Operation Permit" system (<https://uav.aacm.gov.mo>).
- The UA operator permit holder shall be an operator which refers a person or an organisation to conduct the unmanned aircraft operations or offering to engage in unmanned aircraft operations as service provider, but should not be the client who engages the services.
- Completed application form, accompanied by all required supporting documents, shall be submitted by post or e-mail to Civil Aviation Authority – Macao, China.:
