IMPORTANT

- Complete all fields in a clear legible way.
- Do not enter ambiguous information such as "to be determined" or "TBD" in any field. Application form with ambiguous information will be rejected.
- For those fields that are not applicable to this application, enter 'N/A' and the reason of not applicable. Do not leave any field blank unless otherwise specified. Incomplete application form will not be accepted.

Field #	Completion Instructions
1.1	Provide the name and address of the register owner (or the register owner-to-be in case the aircraft is in the process of registration) of the concerned aircraft. This item should correspond with the information on the Certificate of Registration or the application for registration of the aircraft.
1.2	Enter the name and contact information of the person whom the AACM can contact regarding this application.
1.3	Indicate the category of certificate of airworthiness intended in accordance with the Third Schedule of ANRM. This field should correspond with the intended operation of the aircraft. If the intended category is "special category", the purpose of which the aircraft is used shall be specified.
1.4	Indicate whether the application is a new one or a revised one. If this is a revised application, enter the date of the previously submitted application form. Any changes to the application shall be made with a revised application form. Highlight the change(s).
2.1	Enter the aircraft registration mark issued or reserved. Check the appropriate box.
2.2 – 2.8	Self-explanatory.
3	Enter the information of the technical assessment personnel nominated by the applicant.
4	Check the appropriate box only if delegation document is applicable. If delegation document is not applicable, leave the checkbox blank.
5	This field shall be completed by the registered owner (or the register owner-to-be in case the aircraft is in the process of registration). In case of the application is made by a representative of the applicant, proper delegation document such as power of attorney or delegation letter by the applicant shall be enclosed.
